OPERATIONS INSTRUCTIONS:

TO: CG, 80th Inf Div.

1. A telephone call just received from THIRD U. S. ARMY states that CG, XV Corps is concerned regarding coordination between elements XV Corps and 80th Inf Div vicinity ALENCON. If it has not already been accomplished you will establish liaison between your division and ~~CG~~ XV Corps. Old CP XV Corps is located at (V448667). The advance CP is approximately (Q568932). Its exact location is not known.
2. A XX Corps liaison officer just returned from contacting CO 318 RCT just WEST of ALENCON states that he received the impression that even though that RCT had encountered elements of the 90th Div that it expected to go on to the Corps objective shown on ~~the map~~ the overlay accompanying the 80th Div FO for this operation. If this is correct confusion is certain to result. Any such confusion should be eliminated with minimum inconvenience to XV Corps.
3. If it has not already been accomplished liaison will also be established with 1st Inf Div on your left (WEST). 80th Div troops will remain EAST of the Army boundary.
4. All trucks including AAA trucks furnished 80th Div for this operation will be released without delay. They are urgently needed for the move to the EAST.

- ① The situation was described by the C/S XV Corps to Capt. James as "very vague, but we're driving forward."
- ② According to Capt. James the C/S XV Corps this idea of lateral liaison is excellent and is assigning an LNO to work with XX Corps.
- ③ G-3 XV Corps told Capt. James he had sent message to 3rd AD at 0300 to stay off St. Hilaire - Fougères highway, but message was miscarried.

TO : G-3 Section, XX Corps

1. The following points were reported at the 0900 meeting as XV Corps CP this morning:

- a. There is no change in the disposition of XV Corps troops from yesterday.
- b. Between 250 & 300 PWs were taken in DREUX yesterday
- c. On the entire XV Corps front, which includes the ARG-ENTAN sector, PWs from thirteen (13) different German Div were taken.
- d. The German groups that are in contact with XV Corps units have increased from about 40 men to about 200 men each in the last two days.
- e. PWs taken yesterday were 594 bringing the total since 2 August to 11,062.
